- Lessee must provide proof of a valid business license before commencing operations.

# 6. SECURITY & ACCESS

- Suites are equipped with fingerprint door locks and a security system.
- Lessee will receive a digital entry code, which must not be shared.
- The premises shall be accessible to Lessee during extended business hours.

### 7. REPAIRS & MAINTENANCE

- Lessee shall promptly report any damage or necessary repairs to the Lessor.

- Lessee is responsible for any damages caused by their clients or business activities.

#### 8. TERMINATION & DEFAULT

- A 30-day written notice is required for lease termination.

- If Lessee fails to comply with any terms, Lessor may terminate the lease and retain the security deposit.

#### 9. INDEMNIFICATION & LIABILITY

- Lessee agrees to indemnify and hold harmless Signature Suites from any claims arising from their business activities.
